It is obligatory for the PSUs to submit details as asked for by clause No 3 (C) for calculation of Bid Capacity and the clause cannot be replaced by a solvency certificate.
10	Page 2	Refer Row 2 & 3 of Important Information Sheet	Time given for submission after the prebid conference do not seems adequate.  Therefore, it is requested to allow the bidders to submit the bid at least 7-10 days after issue/publication of minutes of pre bid conference.
