As per formula prescribed in the guidelines dated 13.07.2021 issued by Ministry of Ayush.

Interested candidates fulfilling the essential qualification and age limit may apply in the prescribed proforma along-with self-attested copy of certificates in support of age and essential qualification and two passport size recent photographs.
