Age- Not exceeding 55 years as on date of Walk-In-Interview.	Rs. 21,528/- fixed during the contract period.

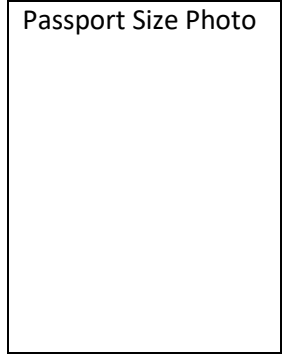
