This is to inform approval of the Competent Authority to entrust the work of Project Management Consultancy service, including architectural and detailed engineering service, statutory approval, construction, procurement, for construction of additional infrastructure of North Eastern Institute of Ayurveda & Folk Medicine Research, Pasighat to H1 bidder Engineering Projects (India) Limited, Guwahati-22.

- 2. The agency fee for Project Management Consultancy including architectural and detailed engineering service, statutory approval, construction, procurement, installation etc. will be 5.50% of construction cost. However, a cap at the fee will be put as 5.50 % of mentioned construction cost or actual cost whichever is less, plus Goods and Service Tax (GST) as applicable under the rules. The total cost of the project is 44.00 Cr. (Construction cost Rs. 42.00 Cr. + Procurement cost 2.00 Cr.)
- 3. It may to be noted that the construction phase of the project along with procurement of the equipment will be 24 months from the date of signing of the Agreement between M/s Engineering Projects (India) Limited, Guwahati-22 and North Easter Institute of Ayurveda & Folk Medicine Research, Pasighat.
- 4. The Terms & Conditions of Project Management Consultancy (PMC) agreement (Scope of work and payment of fee etc.) would be worked out separately as per agreement.
- 5. You are requested to convey your acceptance to undertake the project at the earliest.
