IMPORTANT INSTRUCTIONS (Candidates are to read and scrupulously follow the Instructions) as below:

- 1. A detailed Instruction regarding Screening Test and Assessment Criteria in the Interview is uploaded on the Institute's Website.
- 2. Candidates who are eligible conditionally must produce hard copies of required documents at the Examination Centre.
- 3. Candidates must produce a valid (original) Photo Identity Card (PAN Card, Driving License/Passport/Voter ID/Aadhar Card/IDs) issued by the Govt. Departments/PSUs etc.
- 4. Candidates must report at the Examination Center at least 60 minutes before the examination.
- 5. Please note that entry into the Examination venue shall be closed 15 minutes before the scheduled commencement of the Examination. No Candidate shall be allowed entry into the examination hall after closure of the entry.
- 6. Candidate must use Black Ball Pen in the examination.
- 7. No books, gadgets, etc will be allowed in the Examination Hall. Candidates found in possession of mobile phones/ wrist/smart watch, calculator, Bluetooth device, cameras, pen drives and other electronic gadgets inside the Examination Hall will be deemed to have been using unfair means and would be disqualified.
