**Maximum Number of Participants:** 30 Total (Participants from each state as given)

**Duration:** 03 days (exclusive of journey time)

**Procedure of Application and Submission:** Medical Officer (Ayurveda) working in any Govt. Hospitals North Eastern States having Ayurvedacharya Degree registered under NCISM or State Council/Board. Participants should apply in the enclosed application form duly certified by the Head of the Institution. Duly filled application forms along with a true copy (self-attested) of registration and UG, PG degree certificate & Aadhaar Card should reach the Co-ordinator on or before due date specified against the programme schedule. Application received after the due date or incompletely filled application forms will be rejected. The Applicants should clearly mention "Application for Re-Orientation Training Program for Medical Officer (Ayurveda) North Eastern States on Marma Chikitsa " on the top of the envelope while sending the Application form. **Payment of TA:**

- All Transaction will be made only by electronic transfer through Banks.
- No amount will be paid to trainees except the reimbursement of travelling expenses, that too on actual basis as per the rules subject to ceiling.
- Payment of TA should be made only at the end of the training program after obtaining full attendance as per admissibility or actual, whichever is less.
- Places were connected by rail, will be reimbursed with actual fare limited to AC, 2 tier or actual claim, whichever is less. Tickets are to be done by IRCTC only.
- Road mileage is allowed only for places not connected by rail and that too by Government Transport and proper bills should be submitted. Claimant should mentioned distance between the places.
- The Payment of TA will be made on production of original Tickets by the trainees. The payment will be made as per CME guidelines of Ministry of Ayush.
